Terms and Conditions

#### **INTERPRETATION**

1. In these Terms and Conditions, the following words and phrases shall bear the following meanings :

**'The Company'** means Thermal Detection Ltd, registered number 1886771, whose registered office is at Unit 6, Orde Wingate Way, Primrose Hill Industrial Estate, Stockton-on-Tees, TS19 0GA, United Kingdom.
